I-T dept launches drive against Indians with illegal foreign assets

New Delhi, October 22

THEINCOMETAX department has launched a major operation to investigate cases of illegal funds and properties stashed abroad by Indians and may invoke the new anti-black money law for strict criminal action in many such cases, officials said Monday.

The department, in coordination with its foreign counterparts, is investigating offshore bank deposits and purchases of assets by "thousands of Indians", officials added.

The CBDT chairman Sushil Chandra confirmed the move but refused to elaborate.

Officials, however, said the taxman, armed with vital transaction details of overseas transactions from the financial intelligence unit (FIU) and other

sources, is working on such cases across the country and this was part of a major "concerted" action against black money.

In a number of cases, notices have been issued to individuals or categories of taxpayers to explain their transactions, the officials said.

A number of these cases involve high-profile and prominent people, while several other

net worth individuals are under scanner. However, only those cases will face criminal action under the new black money law which have been reflected before the taxman in the income tax returns (ITRs) or have been done with an intent to evade taxes, they said.

The government brought this new law The Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act - in 2015.

The new legislation deals with cases of overseas illegal assets, which till recently were probed under the Income Tax Act, 1961.

Net direct tax collection grows 15.7% to ₹4.89 lakh cr: CBDT

THE NET DIRECT tax collection in the country grew by 15.7% over year-on-year basis to reach ₹4.89 lakh crore in the current fiscal till third quarter of October, a senior official on Monday quoting from the latest data.

Last year, 1.06 new income tax assesses were added, he added. The present taxpayer base in the country is over 6.26 crore. The department sent about 1.85 crore emails and SMSes to assesses and taxpayers during the last quarter of the last fiscal 2017-18, asking them to file their ITRs.

This marks over 42% of the full-year direct tax collection target of ₹11.5 lakh crore for the fiscal ending March 31, 2019. The CBDT official said the income tax department issued about 2 crore referrals for an amount of about ₹1.09 lakh crore, till last week. The Central Board of Direct Taxes (CBDT) is the policy-making body for the income tax Department (ITD). As per the latest data, the number of taxpayers getting refunds is up by 2% from 1.22 crore refunds in the corresponding period of the last fiscal. In terms of the refund amount, there has been a surge of 31.7% from ₹83,000 crore refunded in the corresponding period last year.

The department, the official said, received 5.8 crore ITRs (ITRs) till October 21 as compared to 5.6 crore returns during the same period of last fiscal.
