

General Meeting, through the electronic voting platform of Central Depository Services (India) Limited ("CDSL"). It was further informed that the Remote e-voting commenced from July 14, 2024 at 9:00 A.M. (IST) and ended on July 17, 2024 at 5:00 P.M. (IST).
