मुंबई हमला : अदालत ने दो गवाहों को तलब किया

इस्लामाबाद, 16 मई (भाषा)।

एक आतंकवाद रोधी अदालत ने बुधवार को 2008 मुंबई आतंकी हमला मामले में अभियोजन के अंतिम दो पाकिस्तानी गवाहों को तलब किया। अदालत ने अधिकारियों को अगली सुनवाई पर 27 भारतीय गवाहों की उपलब्धता पर ठोस प्रतिक्रिया देने का निर्देश दिया ताकि सुनवाई को शीघ्रता से पूरा किया जा सके।

आतंकी संगठन लश्कर-ए-तैयबा के आतंकवादियों ने नवंबर 2008 में मुंबई में आतंकी हमला किया था। इसमें 166 लोग मारे गए थे और दर्जनों घायल हुए थे। आतंकवाद रोधी अदालत 2009 से मुंबई

हमला मामले में सुनवाई कर रही है। यह मामला हाल में उस समय फिर से सुखियों में आया था जब पूर्व प्रधानमंत्री नवाज शरीफ ने एक हालिया साक्षात्कार में कहा कि राज्य से इतर तत्वों ने सीमापार जाकर मुंबई हमले को अंजाम दिया।

'डॉन' ने खबर दी कि अदालत ने बुधवार को सुनवाई बहाल की और जिला पुलिस अधिकारी डेरा गाजी खान सुहेल हबीब तानिक ने न्यायाधीश शाहरुख अर्जुमंद के सामने अपना बयान दर्ज कराया। दो और पाकिस्तानी गवाहों, संघीय जांच एजेंसी के अतिरिक्त महानिदेशक वाजिद जिया और एक अन्य अधिकारी जाहिद अख्तर के बयान अभी दर्ज नहीं हुए हैं।
